Work hours will be established in accordance with office needs and individual school requirements. The student intern will perform and/or be responsible for the following duties:

- Scanning, shredding, copying, filing, stamping, and locating files and documents;
- Assisting with data entry functions and quality control;
- Assisting with front desk duties;
- Pulling criminal history records;
- Attend court proceedings to observe initial appearances, detention hearings and sentencing hearings (as time allows);
- Assist with preparing requests for verification of information (i.e., employment, education, etc.);
- Performing other duties as assigned .

General Information:

- Applicants must be a U.S. Citizen or eligible to work in the United States.
- Background checks will be conducted on final candidate(s).
- The position is a temporary, part-time appointment for services to our district while gaining knowledge, skills and abilities that they can take with them after graduation.

Required Qualifications:

- Applicant must be currently enrolled as a part-time or full-time college student.
- Skill in using scanners and standard office equipment (telephones, copiers, printers, fax machines, paper shredders, computer equipment, etc.)
- Applicant must be mature, responsible, organized, and possess good verbal and written communication skills.
